

**AMENDMENT No. 3 to the AGREEMENT BETWEEN COUNTY OF LAKE
AND REDWOOD COMMUNITY SERVICES, INC. FOR THE LAKE
COUNTY WRAP PROGRAM, FOSTER CARE PROGRAM, AND
INTENSIVE SERVICES FOSTER CARE (ISFC) PROGRAM FOR
SPECIALTY MENTAL HEALTH SERVICES FOR
FISCAL YEARS 2022-23, 2023-24, and 2024-25**

This Third Amendment to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as “County,” and Redwood Community Services, Inc., hereinafter referred to as “Contractor,” collectively referred to as the “parties.”

RECITALS

WHEREAS, the County entered into an Agreement with Contractor for the provision of Specialty Mental Health Services effective July 1, 2022; and

WHEREAS, the Agreement was amended on June 28, 2023 to incorporate CalAIM service and payment reform requirements into the Agreement as well as to increase the compensation payable under the Agreement; and

WHEREAS, the Agreement was amended on March 19, 2024 to include Peer Support Services in the Agreement; and

WHEREAS, the Agreement must be amended a third time to increase the compensation by an additional \$2.1 million dollars for Fiscal Year 2024-25 services.

NOW THEREFORE, based on the foregoing recitals, the parties hereto agree as follows:

Item 3, “Compensation,” is hereby amended to state as follows:

3. COMPENSATION. Contractor has been selected by County to provide the services described hereunder in **Exhibit A**, titled, “**Scope of Services**” attached hereto and incorporated herein. **Compensation to Contractor shall not exceed Five Million, Seven Hundred Thousand Dollars (\$5,700,000.00).**

The County shall compensate Contractor for services rendered, in accordance with the provisions set forth in **Exhibit B**, titled “**Fiscal Provisions**,” attached hereto and incorporated herein, provided that Contractor is not in default under any provisions of this Agreement.

Exhibit B, “Fiscal Provisions,” item 6 is hereby amended to state as follows:

6. PAYMENT TERMS. County shall reimburse Contractor for services provided to Lake County Medi-Cal beneficiaries per the schedule below:

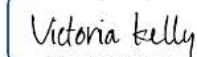
The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
