

**AMENDMENT NO.1 TO THE AGREEMENT BETWEEN COUNTY OF  
LAKE AND REDWOOD COMMUNITY SERVICES, INC. FOR THE LAKE  
COUNTY WRAP PROGRAM, FOSTER CARE PROGRAM, AND  
INTENSIVE SERVICES FOSTER CARE (ISFC) PROGRAM FOR  
SPECIALTY MENTAL HEALTH SERVICES FOR FISCAL YEAR 2025-26**

**This Agreement is made and entered into by and between the County of Lake, hereinafter referred to as “County,” and Redwood Community Services, Inc., hereinafter referred to as “Contractor,” collectively referred to as the “parties.”**

**RECITALS**

**WHEREAS**, the parties entered into an Agreement for the provision of **Specialty Mental Health Services** effective July 1, 2025; and

**WHEREAS**, the County compensates the Contractor for eligible, billable services at a percentage of the Department of Health Care Services (DHCS) published rate; and

**WHEREAS**, following fiscal review and statewide payment-reform implementation, the County now desires to revise the reimbursement percentage from sixty-five percent (65%) to sixty percent (60%) of the applicable DHCS published rate; and

**WHEREAS**, the parties desire to amend the Agreement to clarify payment timing provisions related to undisputed invoices to ensure consistency with County fiscal procedures; and

**WHEREAS**, the parties wish to amend the Agreement accordingly, with all other terms and conditions remaining unchanged and in full force and effect.

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

1. **Exhibit B – Fiscal Provisions**, Section 6 (“Payment Terms”) is hereby amended in its entirety to read:

**6. PAYMENT TERMS**

**From July 1, 2025 through December 31, 2025**, the County shall compensate the Contractor at a rate equal to sixty-five percent (65%) of the applicable Department of Health Care Services (DHCS) published rate for each billable unit of service provided under this Agreement. The DHCS rate in effect at the time the service is rendered shall be used as the basis for calculating payment. This rate applies to all covered services delivered by the Contractor pursuant to this Agreement and is inclusive of all costs associated with service delivery for said period of time.

**Effective January 1, 2026,**

County shall reimburse Contractor for Medi-Cal-eligible services that have been successfully adjudicated and approved for Federal Financial Participation (FFP) at a rate equal to sixty percent (60%) of the applicable DHCS-published rate in effect at the time the service is rendered. In the event of any discrepancy between the rates specified in this Agreement and those published by DHCS, the DHCS-published rates shall govern. Any adjustments to DHCS rates during the term of this Agreement shall take effect immediately upon DHCS publication, without the need for a formal amendment.

This rate applies to all covered services delivered by Contractor under this Agreement and is inclusive of all costs associated with service delivery for said period of time.

This Agreement remains subject to any restrictions, limitations, or conditions imposed by County or State or Federal funding sources that may affect the fiscal provisions or available funding for this Agreement, including reductions in financial participation in the Medi-Cal program. In the event of such reductions, the County agrees to meet with Contractor to discuss renegotiation of the services required under this Agreement.

**2. Exhibit B – Fiscal Provisions, Section 2.6** is hereby amended and restated in its entirety to read as follows:

**2.6 Claiming and Invoicing.**

County shall make payment **within thirty (30) business days following receipt of reimbursement from the Department of Health Care Services (DHCS)** for an undisputed invoice for the compensation stipulated herein for supplies delivered and accepted or services rendered and accepted, less potential deductions, if any, as herein provided. Payment on partial deliverables may be made whenever amounts due so warrant or when requested by the Contractor and approved by the Assistant Purchasing Agent

All other terms, conditions, and provisions of the Agreement remain unchanged and in full force and effect.

County and Contractor have executed this Agreement on the day, and year first written above.
