CURRENT EVACUATIONS:

August 2

-Mandatory Evacuation for Long Valley, High Valley and Spring Valley in Lake County. Leave immediately.

-Mandatory for Western Lake County. West of Lucerne at Bartlett Springs Road and Highway CA-20. South of the fire, east of the fire, north of the Clear Lake, including Blue Lakes, Upper Lake, Nice, Lakeport, Witter Springs, Bachelor Valley, Scotts Valley, Saratoga Springs.

-Mandatory for Bartlett Springs Road, north to Twin Valley Road in the Mendocino National Forest, and east to the western border of the High Valley Ranch. Extending east to the western side of Indian Valley Reservoir.

-Mandatory for Highway 20 area from one mile south of Highway 20, south of McWhinney Creek, east of Potter Valley Road and west of the Mendocino, Lake County line.

-Warning for Midmountain Road region. North of 10551 Eastside Potter Valley Road, east of Eastside Potter Valley Road, west of the Mendocino, Lake county lines, and south of 11385 Eastside Potter Valley Road.

-Warning for Pine Avenue area of Potter Valley north of Burris Lane, south of 10511 Eastside Potter Valley Road, west of Mendocino, Lake county lines and east of Eastside Pottery Valley Road.

EXPIRED EVACUATIONS:

August 2

3:07 p.m. — Evacuation advisory cancelled for areas east of Highland Springs Road, west of Soda Bay Road, and north of the Lake/Sonoma County line and south of Clear Lake. This area includes all of Kelseyville, Buckingham, Clearlake Riviera, Loch Lomond and areas of Red Hills Road, Hwy. 175 Cobb and Bottle Rock Road that were previously under advisory.

3:02 p.m. — Advisory level, residents can return for Southeast Lakeport-North of State Highway 29 at Highland Springs Road, East of State Highway 29, South of Park Way, and West of Clear Lake.
