RESOLUTION AUTHORIZING THE INCREASE OF APPROPRIATIONS IN THE
AMOUNT OF \$40,020.00 FOR PAYMENTS TO SEIGLER VALLEY WETLAND
MITIGATION BANK FOR FMAG HMGP CULVERTS NO. 1 AND NO. 2 PROJECTS

1 WHEREAS, Government Code Section 29125, 29126, 29126.1, and 29130 of the
2 Government Code provide authority for the Board of Supervisors to transfer and revise
3 appropriations, cancel unused appropriations, transfer unused appropriations to
4 contingencies, reduce estimate and cancel and appropriate designations and reserves
5 other than the general reserve; and

7 WHEREAS, the State Water Resources Control Board permits for the construction of
8 the FMAG HMPG Culverts No. 1 and No. 2 Projects required the County of Lake to
9 purchase wetland mitigation credits from a US Army Corps of Engineers approved
10 wetland mitigation bank; and

12 WHEREAS, the Public Works Department selected the Seigler Valley Wetland
13 Mitigation Bank because it is the only US Army Corps of Engineers approved wetland
14 mitigation bank in the County of Lake Service Area; and

16 WHEREAS, the County of Lake will purchase mitigation credits from Seigler Valley
17 Wetland Mitigation Bank in the amount of \$28,635.00 for the Culvert No. 1 Project and
18 in the amount of \$11,385.00 for the Culvert No. 2 Project for a total amount of
19 \$40,020.00 for both projects; and

21 WHEREAS, to pay for the required wetland mitigation credits, it is necessary to
22 transfer funds to Road Division Fund 098, object code 63.01, FMAG HMPG Culverts
23 No. 1 and No. 2; and

25 WHEREAS, to pay for the required wetland mitigation credits, the Auditor/Controller
26 will increase budgetary appropriations in Road Division, Fund 098, object code 63.01,
27 FMAG HMPG Culverts No. 1 and No. 2 in the amount of \$40,020.00 and decrease
28 budgetary appropriations in Road Division, Fund 098, object code 53.55, Other Road
29 Improvements, in the amount of \$40,020.00 after receipt of a certified copy of this
30 resolution.
