AN ORDINANCE AMENDING SECTION 721B. OF THE SEWER USE ORDINANCE, (APPENDIX A), OF THE LAKE
COUNTY ORDINANCE CODE

INCREASING SEWER USE FEES FOR SOUTH LAKEPORT, LANDS END AND REEVES POINT
(A.D. 9-1 AND A.D. 9-3)

The Board of Directors of the Lake County Sanitation District, State of California, ordains as follows:

SECTION 1: The SEWER SERVICE CHARGES in section 721B. of the Sewer Use Ordinance, (Appendix A), of the Ordinance Code of Lake County is hereby amended to read as follows:

"Sec. 721B. - South Lakeport and Reeves Point (A.D. 9-1 and 9-3) Sewer Service Charges. (The fees, tolls, rates, rentals or other charges for services and facilities furnished by the District in connection with its sanitary sewerage system, are as follows:)"
