Fees

This amendment will add an additional \$441,620 to the original contract amount of \$159,711 for project management implementation services. The total amount paid under this contract shall not exceed Six Hundred One Thousand Three Hundred Sixty-One and no/100 dollars (\$601,361). All other provisions of the February 15, 2024 SOW shall remain in effect.
