

**Amendment No. 1 to the AGREEMENT BETWEEN COUNTY OF LAKE
AND PARKVIEW HEALTHCARE CENTER FOR ADULT RESIDENTIAL
AND SKILLED NURSING SUPPORT SERVICES AND SPECIALTY
MENTAL HEALTH SERVICES FOR FISCAL YEARS 2024-25**

This 1st Amendment to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as "County," and Parkview Healthcare Center, hereinafter referred to as "Contractor," collectively referred to as the "Parties."

RECITALS

WHEREAS, the County entered into an Agreement with the Contractor effective July 1, 2024; and

WHEREAS, Exhibit B requires the removal of the duplicate Section 2.2, so that only one Section 2.2 is reflected;

WHEREAS, Exhibit B, Section 6 "Payment Terms," has been modified to accurately reflect the County's payment obligations;

WHEREAS, the parties now desire to amend the Agreement to increase the total compensation payable by \$287,150 for a new contract maximum of \$340,000.00; and must amend item three, "Compensation", to reflect this change.

NOW THEREFORE, based on the foregoing recitals, the parties hereto agree as follows:

Exhibit B Section 2 "Invoices" is hereby amended to state as follows:

2.2 section -Contractor's invoices shall be submitted in arrears on a monthly basis, by the 15th of the following month, or such other time that is mutually agreed upon in writing and shall be itemized and formatted to the satisfaction of the County

Exhibit B Section 6 "Payment Terms" is hereby amended to state as follows:

6. Payment Terms: The County shall County shall reimburse Contractor for services provided to Lake County Medi-Cal beneficiaries per the schedule below:

The county shall pay:

- Patch rate of \$175 per Patient Day, in addition to the Medi-Cal reimbursement rate
- Daily room and board rate for secure/ locked unit: \$650 per day
- Sitter rate: \$850 per day

Section 3 "Compensation" is hereby amended to state as follows:

3. COMPENSATION. Contractor has been selected by County to provide the services described hereunder in Exhibit A, titled, "Scope of Services" attached hereto and incorporated herein. Compensation to Contractor shall not exceed Three Hundred and Forty Thousand Dollars (\$340,000).
