**A RESOLUTION AMENDING RESOLUTION NO. 2025-118 TO AMEND THE FY 2025–26
ADOPTED BUDGET FOR FUND 141 (SUBSTANCE USE DISORDER) BY INCREASING
REVENUES AND APPROPRIATIONS.**

WHEREAS, Government Code Section 29130 provides that anticipated revenue may be made available for specific appropriation by a four-fifths vote of the Board at any regularly scheduled or properly noticed special meeting; and

WHEREAS, revenue and appropriations within the FY 2025–26 Adopted Budget have been reviewed and based on updated Medi-Cal revenue projections and program needs, revisions are necessary; and

WHEREAS, the proposed revisions increase revenues and appropriations in Fund 141 in the amount of \$1,058,700; and

WHEREAS, FY 2025–26 Medi-Cal revenue is projected based on actual billing from July through March (9 months), excluding April due to incomplete reporting, reflecting sustained service utilization levels and expanded service capacity

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Lake, State of California, that it finds, determines, and hereby declares that the County of Lake Adopted Budget for Fiscal Year 2025-2026 is amended as follows:

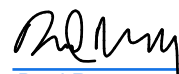
