

Amendment No. 1 to MEMORANDUM OF UNDERSTANDING

Between

LAKE COUNTY BEHAVIORAL HEALTH SERVICES

And

LAKE COUNTY CONTINUUM OF CARE

For COLLABORATIVE APPLICANT AND LEAD AGENCY SERVICES

WHEREAS, on or about February 27, 2024, Lake County Behavioral Health Services (LCBHS) and Lake County Continuum of Care (LCCoC) entered into a Memorandum of Understanding (MOU) Between Lake County Behavioral Health Services (LCBHS) and Lake County Continuum of Care (LCCoC) for Collaborative Applicant and Lead Agency Services; and

WHEREAS, the parties to the MOU now wish to amend the MOU to add street outreach services and

WHEREAS, this Amendment clarifies role of LCBHS providing street outreach to the community in accordance to the Encampment Resolution Grant that LCCoC has received from the California Department of Housing and Community Development (HCD) for the purpose of safely transitioning individuals into stable housing and improve health and safety, of which LCBHS manages in the role of the Collaborative Applicant, including the funding for said activities and

WHEREAS, the LCCoC is subject to federal regulation 24 C.F.R. Part 578, the County's Purchasing Ordinance would not apply and funding of that grant can be transferred to LCBHS to fulfill street outreach activities.

NOW THEREFORE, the parties hereto agree as follows:

The following provisions are hereby added to Section 2, of Attachment 1, "Description of Services", of the MOU:

- C. LCBHS staff will provide street outreach to identify unsheltered encampments across the community.
- D. LCBHS staff will provide referrals and assistance for those that are unsheltered to leave the encampments and seek shelter in more secure locations such as emergency housing in one of three shelters in the community, safe parking, and any other sites that are deemed to provide shelter such as warming centers.

- E. LCBHS staff will enroll those served into the Coordinated Entry System to match individuals with available housing services.
- F. LCBHS staff will provide referrals to additional community services such as behavioral health, medical care, obtaining benefits, domestic violence assistance, education settings, additional housing services, and other community-based services.
- G. LCBHS staff will coordinate encampment site closure with local county and city staff (i.e. law enforcement, code enforcement), health providers, and community-based organizations.
- H. LCBHS staff will utilize LCCoC's Homeless Management Information System (HMIS) to record contacts, numbers serviced, disposition of individuals to housing, and other data deemed necessary by the LCCoC to track progress.
