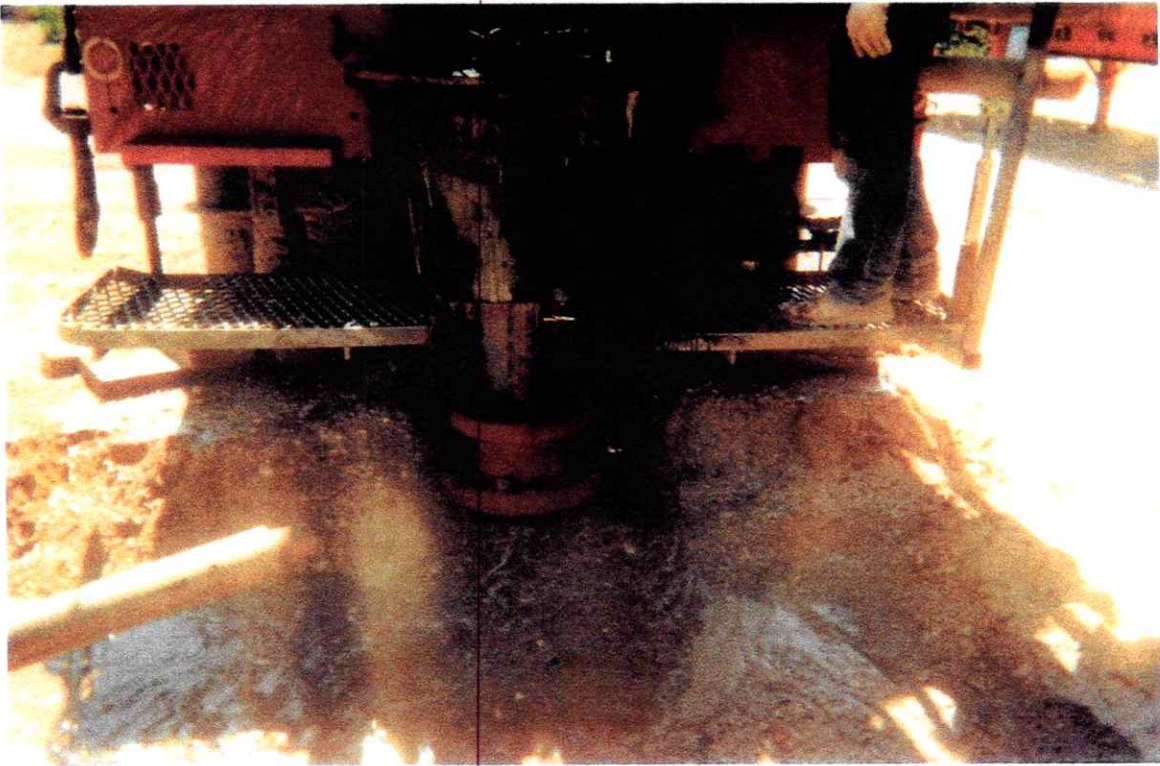

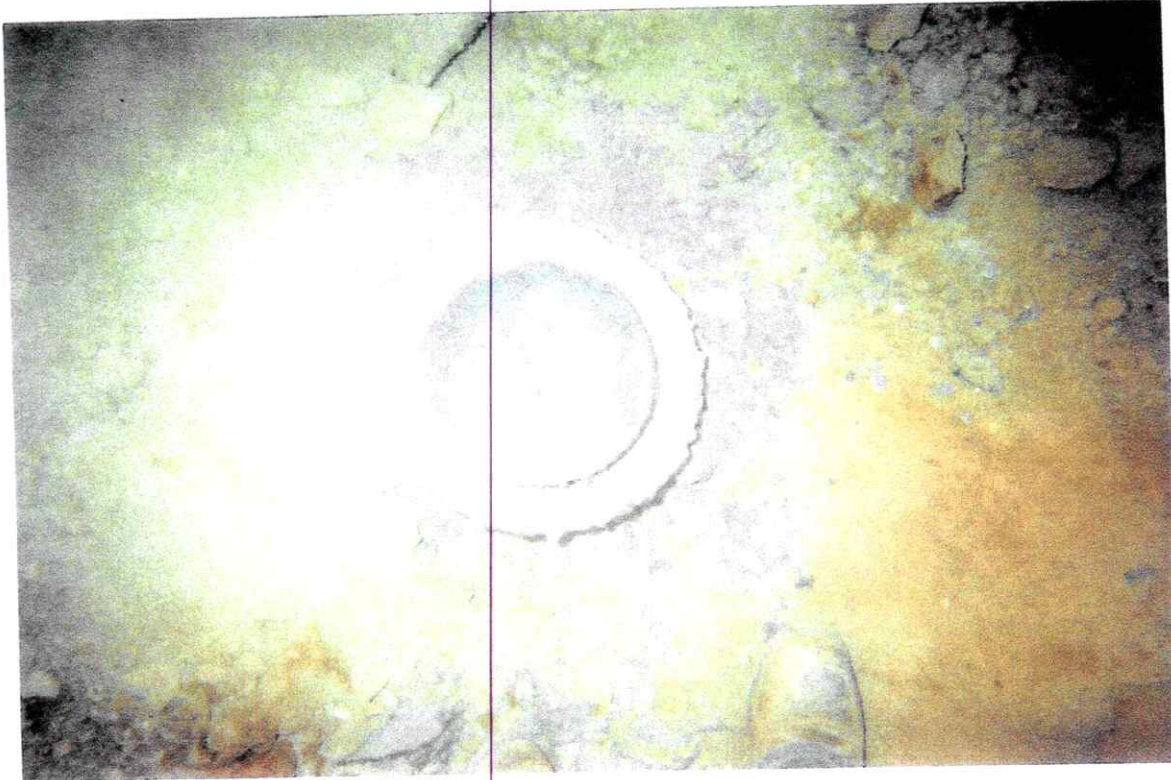

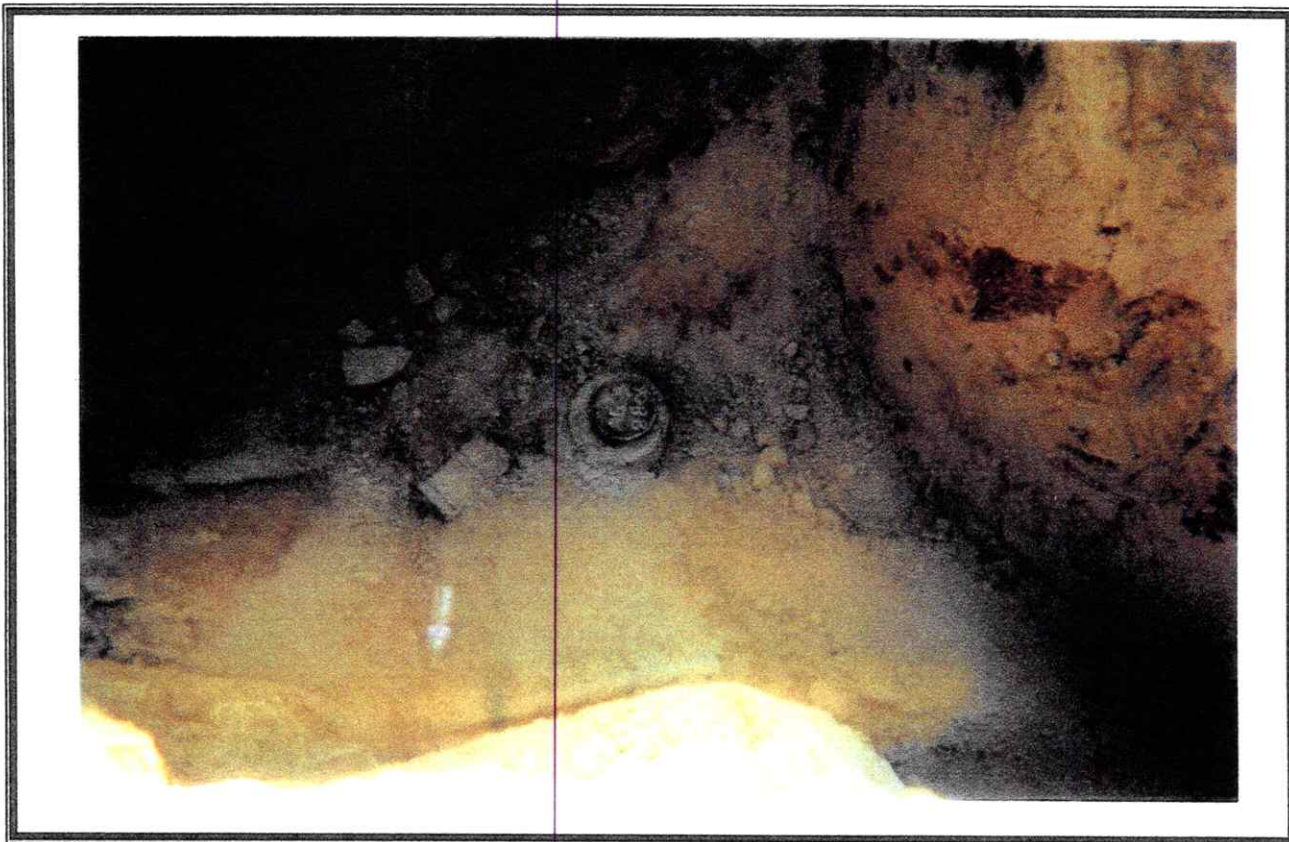

Your proposal to Abandon well "Ag Park" 2, API No. 03390548, Section 32, T 13N, R 8W, M.D., B&M, Lake County, dated, 06/29/2006, received 06/30/2006, has been examined in conjunction with records filed in this office.

A. THE PROPOSAL IS APPROVED PROVIDED THAT:

- a) Adequate blowout prevention equipment shall be installed and maintained in operating condition at all times.
- b) Water of any beneficial use shall be protected from degradation and waste at all times.

B. THIS DIVISION SHALL BE NOTIFIED:

- a) One day prior to the commencement of abandonment.
- b) To witness the placing, location and hardness of cement plug.
- c) To witness the mudding of the hole.
- d) Before altering the proposed program, suspending operations, or placing any cement plugs. Additional requirements will be outlined at that time.
- e) Upon restoration of the location to near original conditions so that a final environmental inspection can be made.
