Dear Chair Crandell and Supervisors:

I write as counsel for Pillsbury Family Farms, Inc. (the “Farm”) regarding the above-referenced cannabis Major Use Permit (“MUP”) appeal. We wish to update you on recent corrective actions taken by the Farm and demonstrate why revocation of its MUP is not warranted. As stated in our April 3, 2025, appeal and as further demonstrated below, our client has been proactive in addressing the issues raised by the Planning Commission and Community Development Director and we believe this Board should not uphold the Commission’s revocation.

We respectfully ask that the Board consider the following developments:

1. Leadership Change – Resignation of Justin Quayle:

One of the reasons the Planning Commission voted to revoke the MUP is the prior disqualification of Justin Quayle, a former officer and director of the Farm. On April 1, 2025, Justin resigned from his roles as an officer and director of the Farm. A copy of the Resignation is attached as Exhibit 1. The Directors of the Farm promptly held a Special Meeting on April 1, 2025, and the Board of Directors accepted Mr. Quayle’s resignation and appointed another person as officer and director in his place. A copy of the Special Meeting of Directors is attached as Exhibit 2. An updated Statement of Information was filed with the California Secretary of State, a copy of which is attached as Exhibit 3.

Mr. Quayle has since completed his onboarding training at the Green Ox distribution center in Eureka, where he is now employed as a sales representative. A copy of Mr. Quayle's new job description is attached as Exhibit 4.

Mr. Quayle no longer holds an official position with the Farm. The LiveScan results for John Evans, CEO, and Skiela Laiwa, CFO and Secretary, are clean and these remaining officers are not disqualified. Thus, the Farm's leadership is in full compliance with all regulatory requirements.

2. Expungement of Record and Background Clearance:

Justin has also taken significant steps to rectify the background check issue that also was a basis for revocation. He petitioned the Sonoma County Superior Court for expungement of his prior criminal records, and the expungement was granted on April 4, 2025. The orders of the Court are attached as Exhibit 5.

Justin's rehabilitative steps and contributions to the community are bolstered by numerous letters of support submitted during his expungement process. Community members and industry peers attested to Justin's positive contributions and personal growth. Copies of those letters are attached as Exhibit 6. Supporters highlighted Justin's contributions to the legal cannabis market (for example, playing a major role in transitioning cultivation into the regulated market), his sincere rehabilitation and law-abiding behavior since his prior incident, and his volunteer work and community service in Lake County. These letters attest to the responsible, hardworking, and dedicated young man that Justin embodies.

Importantly, in an email dated February 7, 2025, Director Mireya Turner acknowledged that the County was "giving [Justin] a little more time to work out [his] background disqualification with the Sheriff's Department," and that the Department had opted not to pursue revocation at that time based on those ongoing efforts. That email is attached as Exhibit 7. Justin took that allowance to heart and that time has now been well-used: he gave up his corporate roles and successfully expunged his record, thus removing any basis for disqualification. The Farm respectfully submits that these corrective steps close the issue entirely and reflect the exact type of good-faith compliance the County encouraged.

In light of these efforts and the Court's approval of his expungement, Justin's past issues have been resolved, and he poses no risk or barrier to the Farm's compliant operations.

3. Proactive Compliance Measures in 2022:

The Farm has a proven record of cooperation with county regulations. In 2022, at the direction of the County, the Farm initiated an abatement of its crop following a severe snowstorm that damaged its cultivation area. Out of an abundance of caution and commitment to compliance, the Farm disposed of the affected cannabis plants in accordance with County expectations. This was later confirmed by Director Turner who stated in a disclosed recorded meeting held on November 2, 2023, "[t]he snow disturbed or destroyed the crop and you cleaned

it up and threw it out and disposed of it” and that “we did not need to go forward. It was self-abated by the permittee.” A transcript of that meeting is attached as Exhibit 7 (00:00:13 – 00:00:32; Director Turner is “Speaker 1”).

During the same meeting, Director Turner further acknowledged that although cultivation without a state license is generally considered a high-severity violation, she and her staff were of the view that the Farm was “trying really hard to get this stuff done and squared away with the state,” and were one of the “people that the Board tells us we have to support.” Based on these assurances and the Farm’s self-abatement, good-faith engagement, and progress on licensure, Director Turner made the decision not to recommend revocation stating: “I decided, I’m not putting you on the revocation list.” (Exhibit 7, 00:02:17.)

This acknowledgment by the Planning Department reflects an informed determination that the Farm was acting in good faith, cooperating with regulators, and moving toward full compliance. As further validation of those efforts, the Farm’s State cultivation license was officially issued on July 24, 2023.

The Farm has consistently demonstrated a compliant approach in its operations. The company has promptly addressed every concern raised by authorities, showing an earnest willingness to correct any issues. This cooperative track record includes maintaining open communication with the County, adhering to all cultivation regulations, payment of all taxes including the County cannabis business tax, and investing time and resources to meet both County and State requirements. The Farm also consistently pays its County cultivation taxes in full and before the applicable deadlines, further evidencing its commitment to lawful operations. This history of good-faith compliance in combination with Justin’s current efforts weighs heavily in favor of allowing the Farm to continue its licensed operations under the MUP.

Moreover, the Farm’s presence has been a positive force in the local regulated cannabis economy. As one of the licensed operators in Lake County, the Farm contributes to the local economy through job creation and participation in the legal market, helping to suppress unregulated activities.

Also, there is no ongoing public safety risk associated with the Farm’s activities. All cultivation is conducted under proper licenses and oversight. With Justin’s departure from management and his related actions, any past compliance concerns have been fully mitigated.

Importantly, the County previously recognized the Farm’s dedication to compliance. When issues have arisen, the Farm worked with officials to resolve them and the County in turn allowed the Farm to continue operating as long as it was making progress (as evidenced by the Planning Commission’s decisions in 2022). The Farm is simply asking for that same fair and reasonable consideration now. The purpose of the cannabis regulatory program is to encourage operators to come into compliance and remain in good standing – the Farm has done exactly that.

For all the reasons above, the Farm respectfully requests the Board not revoke its use permit. The extraordinary steps it has taken – removing Justin from ownership and official

positions, clearing Justin's record, and maintaining compliance with licensing requirements – ensure that the conditions which led to the permit issues have been remedied. Revocation at this stage would only punish a community-minded business that has worked hard to align with all regulations. Instead, allowing the Farm to continue operations under the MUP will encourage ongoing compliance and benefit the community by keeping a responsible operator in the legal market.

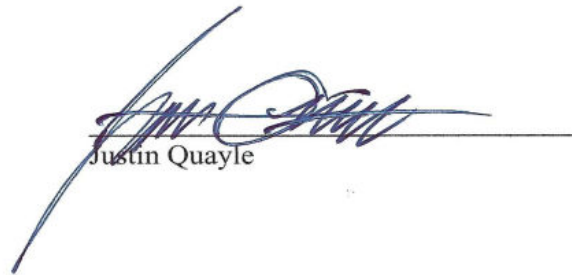

Speaker2: [00:01:37] Not that part. The part before that, I understood that part, but it was about how you had to go to somebody to let them know. And the cannabis?

Speaker1: [00:01:51] I'm sorry. I don't remember what you're asking me to repeat. Okay, so let me start over. Let me start over. Hold on.

And I as I talk to staff more, we all were of the firm belief that you were trying really hard to get this stuff done and squared away with the state. And so we really thought that you are one of these people that the board tells us we have to, to support. And so at that point, with the addition of the snowstorm, then that came in and destroyed your crop and you just disposed of it on your own. At that point, I decided, I'm not putting you on the revocation list because you guys then subsequently also were working with the state, which the state reported to us. So the way I see it, you guys are doing everything you can to have a successful and legal business. That's where we are now. So then at our at this last site visit, the only, the only thing that we saw that needed some correction was just that greenhouse which needs a demolition permit. But I have no other data that shows me that you're anything other than in good standing.
