

**AMENDMENT NO. 2 TO AGREEMENT FOR PROFESSIONAL SERVICES BETWEEN
THE COUNTY OF LAKE AND LAKE COUNTY PEG-TV**

This Amendment No. 2 to Agreement is made and entered into this 19th day of December, 2025 by and between the COUNTY OF LAKE, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and Lake County PEG-TV (hereinafter referred to as "CONTRACTOR").

RECITALS

WHEREAS, the parties hereto have entered into an Agreement dated June 11, 2024 under which CONTRACTOR will provide videography services to COUNTY; and

WHEREAS, the parties approved the 1st amendment to the agreement on March 18, 2025 to increase the compensation for FY 24-25 to a maximum not to exceed \$17,000; and

WHEREAS, the parties desire to further amend the Agreement to increase the compensation of the agreement for FY 25-26.

NOW, THEREFORE, the parties hereby agree as follows:

1. Section 2 – Contractor Compensation is hereby amended to read:

"COUNTY shall compensate CONTRACTOR for said services at the rate described in Exhibit C, not to exceed \$17,000 for FY 24/25, \$22,000 for FY 25/26, and \$10,000 for FY 26/27 and shall be based upon a written statement from CONTRACTOR detailing the services provided using the process described in Exhibit C, attached hereto and incorporated herein by reference, titled Fiscal Provisions. Contract shall commence upon the date of approval from the Lake County Board of Supervisors and terminate on June 30, 2027."

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
