

JUSTIFICATION OF PROPOSAL
for review by
Local Agency Formation Commission

Chapters 6.5 and 6.6 of Part 1, Division 2, Title 5 of the Government Code charge the Local Agency Formation Commission with responsibility for the review and evaluation of proposals for the formation of, or annexation to, local agencies. As provided in the sections of the code referred to above, the factors to be considered by the Commission in reviewing such proposals shall include but not be limited to:

- (1) Population; population density; land area and land uses; per capita assessed valuation; topography, natural boundaries, and drainage basins; proximity to other populated areas; the likelihood of significant growth in the area, and in adjacent incorporated and unincorporated areas, during the next 10 years.
- (2) Need for organized community services; and present cost and adequacy of governmental services and controls in the area; probable future needs for such services and controls; probable effect of the proposed formation and of alternative courses of action on the cost and adequacy of services and controls in the area and adjacent areas.
- (3) The effect of the proposal, and of alternative actions, on adjacent areas, on mutual social and economic interests and on the local governmental structure of the county.

In order to facilitate the Commission's review of your proposal it will be necessary for you to complete the following questionnaire and file the same together with the appropriate notice of intention relating to your proposal. All questions must be answered; if the question is not applicable to your type of action, you may so state. Pursuant to the rules of the Commission, no notice of intention will be accepted for filing unless accompanied by this completed questionnaire.

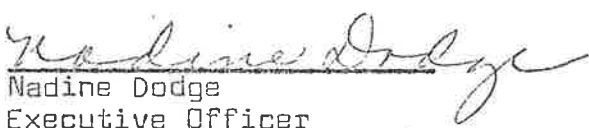

Petition for a Scotts Valley Water District

We the following property owners and/or registered voters within the boundaries of the proposed Scotts Valley Water District hereby petition for the said Water District believing:

1. We can best conserve and enhance our water supply and riparian rights by joining together in such a district.
2. Projects now proposed, such as the Scotts Creek Dam, and interim measures, such as flash dams and the preservation of vital water bearing gravels in the creek beds can better be promoted by group endeavor than by individual action.
3. A district at the grass-roots covering such a natural basin as the area proposed in Exhibit #C would provide a legal entity for governmental agencies to consult with in the solution of mutual and area and water and flood control problems and projects. Without such a district agreements arrived with individuals could adversely affect the far greater majority of the properties involved.
4. It is not the desire of growers to resort to legal action to preserve our water rights with the City of Lakeport if mutual problems can be resolved through discussion. However, without an authorized body (i.e. The Water District) the threat of individual and/or class action will remain. Each grower will be forced to act in his own interest to protect his riparian rights and the value of his property. Thus, a District is vital to the resolution of present water problems if an understanding, other than court action, is to be reached.
5. Looking to the future - A district would enable the area to act in concert to solve problems of available water and its distribution in the area. It could also be effective in matters of flood control, which with Valley Subsidence, is becoming a major drainage problem.
- 6- Both increasing available water in the summer months and reducing the flooding in the winter and spring could be done better by a district working cooperatively with existing governmental agencies.

Here the district would be an effective instrument for the local, State and Federal agencies to work with in resolving present and future water and water control needs.

CONCLUSION

Serious damage by subsidence in the central Scotts Valley area has already occurred. This subsidence threatens to worsen affecting not only the underground storage in basin, but also flooding and drainage during high water periods.

The water shortage problems must, somehow, be met. The agricultural area is dependent upon a reliable water supply during the growing season. Both the sizing of our fruit and health and vigor of our trees depends upon meeting the moisture requirement.

These factors affect every property owner and has a serious adverse affect on the economic well-being of the Valley.

Such economic conditions could also seriously effect the tax base of the area and business conditions in Lakeport, and the surrounding areas.

Believing that self-government can help resolve these problems of the present and the future we earnestly petition for the formation of the above mentioned district.
